## 1. INVITATION FOR BIDS

- Mangalore SEZ Limited (MSEZL) is jointly promoted by Oil & Natural Gas Corporation Ltd. (ONGC), Infrastructure Leasing & Financial Services Ltd., Karnataka Industrial Areas Development Board (KIADB) and Kanara Chambers of Commerce and Industries (KCCI). ## 7. Scope of Work for Real Time Monitoring System will be but not limited to

- a. The supply, installation, testing and commissioning of online analysers for the parameter like pH, BOD, COD, TSS, Ammoniacal Nitrogen & Turbidity as per the CPCB/KSPCB guidelines. The measuring range for the parameters are given below:
  - a. pH 6.5 to 8.5
  - b. BOD 0 to 10mg/l
  - c. COD 0 to 50mg/l

- d. TSS 0 to 10 mg/l
- e. Turbidity 0 5 NTU
- f. Ammoniacal Nitrogen 0 -10mg/l
- b. The monitored data to be transferred to CPCB/KSPCB server on real time basis.
- c. The analysers should be installed at the outlet of treated water storage tank or pumping line as per the CPCB guidelines. The materials required for the installation of same is under the scope of contractor.
- d. The tapping of the power (UPS) required for the analyser from the nearest source is under the scope of contractor.
- e. MSEZL will provide GSM sim with internet provision for synchronizing monitored data with PCB server.
- f. The contractor should provide 1 year warranty for all instruments (During warranty, free service to be provided including site visit).
- g. MSEZL has installed a flowmeter at the outlet of TTP, the contractor should provide provision for display of pumping quantity along with other parameters and data to be synchronized with PCB server.
